
1. What is verification?



- It is a process used by schools to:
- Confirm information reported on the Free Application for Federal Student Aid (FAFSA) or the free Washington Application for State Aid (WASFA) is accurate
- Verify information with documentation and signed forms provided by student and parents, if applicable
- Determine student eligibility for financial aid

3. WHY DO STUDENTS GET SELECTED FOR VERIFICATION?



- The Department of Education randomly selects applications to go through this process to test which FAFSAs may contain errors.
 - to ensure that their limited dollars go to students with the highest financial need
- Resolve conflicting information that will change the student's expected family contribution (EFC) or information that is used to determine the student's eligibility for financial aid.

5. LEARN WHAT DOCUMENTS YOU MAY NEED TO COLLECT

TAX FILERS

- 2021 tax data has been transferred via IRS DRT; or,
- Tax return transcript has been submitted from the IRS; or,
- A signed copy of the 2021 income tax return (and applicable schedules) that were filed with the IRS has been submitted.
- A signed copy of foreign tax return

NON-TAX FILERS

- Income earned from work (W2, 1099) or request Wage & Income transcript from IRS
- IRS documents indicating that it does not have a tax return record on file for the tax year (record of account transcript—as opposed to tax account transcript; request using form 4506-T)
- A signed statement certifying the individual has not filed and is not required to file 2021 taxes and the sources of 2021 income earned from work and the amount from each source.

EXTENSION FILERS

- (BEYOND 6 MOS. ALLOWANCE)
- A copy of the IRS's approval of an extension beyond the automatic sixmonth extension for tax year 2021;
- Verification of non-filing from the IRS dated on or after October 1, 2022;
- A copy of IRS Form W–2 for each source of 2021 employment income received or an equivalent document; and,
- If self-employed, a signed statement certifying the amount of AGI and U.S. income tax paid for tax year 2021



5. LEARN WHAT DOCUMENTS YOU MAY NEED TO COLLECT

IRS Tax-Related Identity Theft

Provide an alternate tax transcript known as the Tax Return Database View (TRDBV) transcript; and a statement signed and dated by the tax filer indicating that s/he is a victim of IRS tax-related identity theft and that the IRS has been made aware of the tax-related identity theft. Identity Protection Specialized Unit (IPSU) tollfree number at 1-800-908-4490.



5. LEARN WHAT DOCUMENTS YOU MAY NEED TO COLLECT

Individuals without Social Security Number

- Signed statement from taxpayer certifying they do not have a Social Security Number, an Individual Taxpayer Identification Number, or an Employer Identification Number; and
- List sources and amounts of earnings, other income, and resources that supported the individual(s) for the 2021 tax year



5. LEARN WHERE TO GET TAX RETURNS

Tax returns

- Signed Copies of Tax Returns and Applicable Schedules
 - from your records or your tax advisor
- Unsigned Tax return transcript www.irs.gov
 - Use the "Get Transcript Online" option on the IRS website or IRS2Go app to view, print, or download a copy in real time as a Portable Document Format (PDF) file, which may be submitted to the school;
 - Use the "Get Transcript by Mail" option on the IRS website or IRS2Go app to submit a transcript request online and receive the transcript by mail to the tax filer's IRS address of record within 5 to 10 calendar days;
 - Call 1.800.908.9946 to receive the transcript by mail to the tax filer's IRS address of record within 5 to 10 calendar days;
 - Mail or fax a paper request IRS Form 4506-T (Request for Transcript of Tax Return) or 4506TEZ (Short Form Request for Individual Tax Return Transcript), both of which are available on the IRS website, to have the transcript mailed to the tax filer's IRS address of record.
- Signed rollover proof/documentation
- Signed Nontax filer statements



5. IDENTITY/STATEMENT OF EDUCATIONAL PURPOSE


Proof of Identity

- Student must appear in person at the college's financial aid office or appear in person with a notary. Online notaries are not accepted by the Department of Education.
 - If a student cannot appear in-person at their college suggest using notary services through their bank to avoid additional expenses
- Present an unexpired government-issued picture ID (state ID, U.S. Passport, tribal ID from federal recognized tribe) which the financial aid office must retain a copy
 - Military IDs are not accepted since it is against the law to make a copy

Statement of Educational Purpose

Sign a statement that financial aid received for the 2023-24 year will be used for educational purposes, typically provided by the college

6. PLAN YOUR STRATEGY



- As soon as you receive your Student Aid Report, review it carefully and determine if you will need to submit documents
- Request copies of tax return transcripts, or record of account transcript or verification of non-filer to the IRS EARLY
- Check your colleges' student portal and email for additional instructions from the financial aid office <u>regularly</u>


7. REDUCE YOUR ANXIETY


